**WATER TOWER REPAIR:** Motion by David Earley, second by Brian Beckrow, authorizing Manager Reno to sign the Agreement with Spicer Engineering to provide professional engineering services related to the final design of the painting and repairs to the 250,000-gallon elevated water storage tank, total fee of \$9,800.
