PUBLIC HEARING/SPECIAL MEETING

September 8, 2020

CALL TO ORDER: The Public Hearing and Special Meeting of the Richland Township Board of Trustees was called to order by Supervisor Frederick at 6:30 P.M.

PUBLIC HEARING: Supervisor Frederick opened the Public Hearing to hear comments regarding the Fire and Police special assessment millage rates to be levied on the 2020 winter tax roll for operation during the 2021-2022 fiscal year. The Fire Department requests an increase of 1.0 mills to the current 1.8 mills for maintenance and repairs to the fire department building and parking lot. The Police Department desires to remain at the current 3.0 mills.

ADJOURN HEARING: Motion by Susan Neuenfeldt, second by David Earley, to adjourn the Public Hearing. Unanimous vote. Motion carried – 6:33 P.M.

CALL TO ORDER – SPECIAL MEETING: Supervisor Frederick called the Special Meeting to order following the Public Hearing to establish police and fire special assessment millage rates to be levied on the 2020 winter tax roll for operation during the 2021-2022 fiscal year at 6:33 P.M.

POLICE MILLAGE: Motion by Renee Herhold, second by Susan Neuenfeldt, to levy three point zero (3.0) for the police special assessment on the 2020 winter tax roll for operation during the 2021-2022 fiscal year. Roll call vote Earley, yes; Frederick, yes; Herhold, yes; Neuenfeldt, yes. (4) yeas, (0) nays, (1) absent. Motion carried.

FIRE MILLAGE: Motion by Susan Neuenfeldt, second by Renee Herhold, to levy two point zero (2.0) for the fire special assessment on the 2020 winter tax roll for operation during the 2021-2022 fiscal year, with the additional funds to be designated for the needed maintenance and repairs to the fire department building and parking lot. Roll call vote Earley, yes; Frederick, yes; Herhold, yes; Neuenfeldt, yes. (4) yeas, (0) nays, (1) absent. Motion carried.

PUBLIC COMMENT: Questions were raised and answered.

ADJOURN SPECIAL MEETING: Motion by Susan Neuenfeldt, second by David Earley, to adjourn the Special Meeting. Unanimous vote. Meeting adjourned – 6:55 P.M.
