## **PUBLIC HEARING/SPECIAL MEETING**

**CALL TO ORDER:** The Public Hearing and Special Meeting of the Richland Township Board of Trustees was called to order by Supervisor Frederick at 6:30 P.M. with the Pledge to the Flag.

**PUBLIC HEARING:** Supervisor Frederick opened the Public Hearing to hear comments regarding the Fire and Police special assessment millage rates to be levied on the 2017 winter tax roll for operation during the 2018-2019 fiscal year. The Fire Department is seeking an increase from the current 1.2 mills, with a presentation showing the needs of the Department for compliance. The Police Department would like to remain at the current 3.0 mills. Comments and questions were received and answer.

**ADJOURN HEARING:** Motion by Susan Neuenfeldt, second by David Knoll, to adjourn the Public Hearing. Unanimous vote. Motion carried – 6:52 P.M.

**CALL TO ORDER – SPECIAL MEETING:** Supervisor Frederick called the Special Meeting to order following the Public Hearing to establish police and fire special assessment millage rates to be levied on the 2017 winter tax roll for operation during the 2018-2019 fiscal year at 6:52 P.M.

**POLICE MILLAGE:** Motion by Renee Herhold, second by Susan Neuenfeldt, to levy 3.0 mills, keeping the same millage rate as the previous year, for the police special assessment on the 2017 winter tax roll for operation during the 2018-2019 fiscal year. Roll call vote Neuenfeldt, yes; Earley, yes; Herhold, yes; Frederick, yes; Knoll, yes. (5) yeas, (0) nays. Motion carried.

**FIRE MILLAGE:** Motion by David Knoll, second by Susan Neuenfeldt, to levy one point eight (1.8) mills, an increase from the 1.2 mills as set for the previous year, for the fire special assessment on the 2017 winter tax roll for operation during the 2018-2019 fiscal year. Roll call vote Earley, yes; Herhold, yes; Frederick, yes; Knoll, yes; Neuenfeldt, yes. (5) yeas, (0) nays. Motion carried.

**PUBLIC COMMENT:** Comments were received and answered.

**ADJOURN SPECIAL MEETING:** Motion by Susan Neuenfeldt, second by David Knoll, to adjourn the Special Meeting. Unanimous vote. Meeting adjourned – 7:13 P.M.
